What and when contributions can be made

The table below summarises the types of super contributions you can make with these slips and the circumstances surrounding when contributions can be made.

Use the front of the slip to make personal contributions to your **HOSTPLUS** Executive account. Use the back of the slip if you wish to contribute to your spouse's **HOSTPLUS** Personal Super Plan account or if your spouse wants to contribute to your **HOSTPLUS** Executive account.

| | Spouse* | Can be made at any time, irrespective of the age and employment status of the receiving spouse. | Can be made if the receiving member has been gainfully employed at least 40 hours in 30 consecutive days during the financial year. | Not allowed. | |

* Regardless of age, spouse contributions require the couple to be living together on a genuine domestic basis and for them to both be Australian residents. The receiving spouse can't be employed by the contributing spouse. Please note that Government regulations don't apply to same sex couples or married couples who live apart.

How to make a contribution

Step 1:

If making a personal contribution into your **HOSTPLUS** Executive account:

- Fill in the front of the slip,
- Make your cheque out to 'HOSTPLUS Executive', and
- Write your membership number on the back of your cheque.

For spouse contributions:

- Fill in the back of the slip,
- Make your cheque out to 'HOSTPLUS', and
- Write the receiving spouse's membership number on the back of the cheque.

Step 2:

Send your completed slip and cheque to the postal address listed on the back of this booklet.

Step 3:

Keep a record of your payments on the inside back cover of this booklet.
